PARTICIPATION AGREEMENT - FOR THOSE UNDER 18 YEARS OF AGE
By signing this document you will waive certain legal rights, PLEASE READ CAREFULLY.

CONDITIONS OF REGISTRATION

1. The Lake Simcoe Soccer Club Inc. will attempt to accommodate every participant. Places, however, will be limited and acceptance of every registration cannot be guaranteed.
2. ONLY THE APPOINTED COACH'S CHILD OR TEAM SPONSOR'S CHILD WILL BE PRE-ASSIGNED TO A TEAM. The LSSC will not guarantee that any player will be allocated to a specific team, coach or field.
3. To make teams as balanced as possible; all players will be placed on teams randomly, unless the players are siblings or children of the coach or sponsor. The LSSC reserves the right to move players between teams within the club for balancing purposes.
4. The club will attempt to ensure equal playing time for all players. IF, however, any player is absent for any combination of more than 4 practices or games, the right to equal playing times shall be at the discretion of the coach.

CONSENT OF USE OF PERSONAL INFORMATION:

I authorize the Lake Simcoe Soccer Club Inc. (LSSC) to collect and use personal information about myself/my child/ward, including name, address, email, telephone number, cell phone number, sex, age, date of birth, proof of age and any other additional information required by the Club for its own needs for the following purposes:

- To constitute soccer teams according to age, gender, physical and skill 'criteria'
- To provide for volunteer staff for coaching and administrative purposes
- To register players for informational and insurances purposes with the Ontario Soccer Association (OSA) and various leagues in which LSSC players may participate and to have players assigned to an OSA registrant number
- To comply with tournament requirements, where in addition to the registration information, herein, player photos will be required and submitted for review by league and tournament officials
- To constitute and maintain a list of club members, for contact by the LSSC from time to time for the distribution of information by telephone, email and mail
- Information collected will be stored for the shorter of up to ten years, or specific request for deletion by a registrant, and available for correction or review
- Registrant pictures to be published on website and newspapers

Furthermore, I authorize the Canadian Soccer Association, The Ontario Soccer Association, York Region Soccer Association, and Lake Simcoe Soccer Club to collect and use personal information about my child/ward for the purpose of receiving communications from the Canadian Soccer Association, The Ontario Soccer Association, District, League and Club. ACCEPTANCE OF TERMS AND CONDITIONS

In consideration of the acceptance of my membership in the Ontario Soccer Association, District Association and Club, I, the parent/guardian of the player, agree as follows:

1. I understand that my child/ward cannot play in any sanctioned soccer game until after this registration form has been validated and the registration data has been entered in The Ontario Soccer Association's computerized registration system.
2. I have reviewed the waiver/participation agreement and my signature affixed hereto indicates my agreement with such waiver/participation agreement.
3. I am aware of The Ontario Soccer Association, York Region Soccer Association, Lake Simcoe Soccer Club and League bylaws, policies, rules and regulations and agree to abide by them and to be bound by them.
4. I accept sole responsibility for my child/ward's personal possessions and athletic equipment.
5. I accept all liability for any damage to the playing equipment caused by my child/ward's careless, negligent and/or improper handling.

I acknowledge that I have read this registration agreement in its entirety and that I have executed this registration agreement voluntarily.

IN CONSIDERATION of allowing my minor child/ward (as named on this registration form) to participate in the programs, activities and events of The Ontario Soccer Association, District Association and Club

I ASSURE TO YOU THAT:

1. I am the parent/guardian of the named participant having full legal responsibility for decisions regarding the named participant.
2. I believe that my minor/ward is physically, emotionally and mentally able to participate in the programs, activities and events of The Ontario Soccer Association.
3. I hereby acknowledge that I am aware of the risks and hazards associated with or related to soccer. The risks and hazards include, but are not limited to injuries from:
Executing strenuous and demanding physical techniques in soccer; Dryland training including weights, running and massage; Grass, turf and other surfaces including bacterial infections and rashes; Falls to the ground due to uneven or irregular terrain or surfaces; Collisions with walls and soccer equipment; Failure to properly use any piece of equipment or from the mechanical failure of any piece of equipment; Extreme weather conditions which may result in heatstroke, sunstroke or hypothermia; Contact, colliding or being struck by other participants, spectators, equipment or vehicles; Vigorous physical exertion and strenuous cardiovascular workouts; Exerting and stretching various muscle groups; and Travel to and from competitive events and associated non-competitive events which are an integral part of the organization's activities.
4. Furthermore, I am aware that my child/ward may:
 - a. Sustain injuries in soccer that can be severe, cause spinal cord injuries and even be fatal;
 - b. Experience anxiety while challenging himself/herself during the activities, events and programs;
 - c. Come into close contact with other participants, including the possibility of accidental and unexpected contact;
 - d. Risk of injury is reduced if he/she follows all rules established for participation; and
 - e. Risk of injury increases as he/she become fatigued.

I UNDERSTAND AND AGREE, on behalf of myself, my heirs, assigns, personal representatives and next of kin that my signing of this document constitutes:

1. I am registering my child/ward willingly and my child/ward is participating voluntarily in these activities, events and programs.
2. I agree that there are risks in soccer as described above and my child/ward will be exposed to these risks and hazards.
3. I agree to accept all these risks and hazards and be responsible for any injury or other loss which my minor child/ward might receive while participating in these events, activities and programs.
4. If something happens to my child/ward, I release the Organizers of responsibility for any claims, demands, actions and costs which might arise out of my child/ward's participation. I understand "Organizers" to mean: The Ontario Soccer Association, District Associations, Leagues, Clubs and their directors, officers, members, employees, volunteers, officials, participants, clubs, agents, sponsors, owners/operators of facilities, and representatives.

ACCIDENT INSURANCE

Executing this agreement will not preclude you from accident insurance coverage, subject to the terms and conditions of The Ontario Soccer Association's insurance policy.
